COVER MESSAGE

Ms. Black (#1001181269),

Per our conversation, please find a screenshot of the IRS site demonstrating our status as of yesterday February 18, 2015.

Our situation started February 17th when we attempted to apply for sponsorship via a corporate sponsored Cybergrant website. We were advised the IRS did not have us listed in their database.

The next day I called and spoke to Ms. Espelhve (She did not offer an ID number as those that followed). She was kind enough to walk me through the process of searching the IRS website at <http://www.irs.gov/Charities-&-Non-Profits/Exempt-Organizations-Select-Check> where it was confirmed that Ride for CHANGE Ride for HOPE Foundation was a recognized not for profit. A copy of the website as showed on my screen yesterday was saved on my hard drive. A copy of that screenshot is attached to this fax.

This morning I called and spoke to Ms Key (ID #10001961) at about 9:59AM CST where I explained how last night I attempted to apply again using a Cybergrants.com website only to be notified once more that Ride for CHANGE Ride for HOPE Foundation was not listed in the IRS database.

Ms Key and I went to the IRS site where we found that the Ride for CHANGE Ride for HOPE Foundation status verified yesterday was no longer there rendering our status unverifiable. Somehow during the call we were disconnected.

I called back and spoke with Ms. Black (#1001181269) who also searched with me only to find our status again, unverifiable. The Master File was searched also. We are listed in the downloadable Master File. However, the corporations we are approaching use Cybergrants.com to screen and process their applicants. The Master File does not help in this regard.

Our status was verifiable in the afternoon of Feb. 17th and later that evening not verifiable. How could this be? Why was it removed? How can we get it back online ASAP so that we may seek the funding necessary to accomplish our mission as time is of the essence.
